KANUN TANAH NEGARA 1965  
(56 tahun 1965)

KAEDAH-KAEDAH TANAH MELAKA (PINDAAN) (No. 2) 2011

PADA menjalankan kuasa yang diberi oleh seksyen 14 dan 445 Kanun Tanah Negara 1965 [56 tahun 1965], Pihak Berkuasa Negeri Melaka membuat kaedah-kaedah seperti berikut:

**Nama dan permulaan kuat kuasa**

1. Kaedah-Kaedah ini bolehlah dinamakan **Kaedah-Kaedah Tanah Melaka (Pindaan) (No. 2) 2011** dan hendaklah disifatkan mula berkuat kuasa pada tarikh ianya diwartakan.

**Pindaan subkaerah 20(1)**

2. Kaedah-Kaedah Tanah Melaka 1966 [*M. P.U. 3/1966*] yang dalam Kaedah ini disebut “Kaedah ibu” adalah dipinda dengan—
- (a) menggantikan perkataan RM3000.00 yang terdapat dalam Jadual Item 66A di ruangan *Fees* kepada perkataan RM4000.00 atau 2% daripada harga jualan, mana yang lebih tinggi; dan

(b) memasukkan butiran Jadual bagi Item 66B yang baru selepas Item 66A seperti berikut;

### NATIONAL LAND CODE 1965

(56 of 1965)

### MALACCA LAND RULES (AMENDMENT) (No. 2) 2011

IN exercise of the powers conferred by sections 14 and 445 of the National Land Code 1965 [56 of 1965], the State Authority of Malacca makes the following rules:

#### Citation and commencement

- These rules may be cited as the **Malacca Land Rules (Amendment) (No. 2) 2011** and shall come into force on the date of its publication in *Gazette*.

**Amendment of subrule 20(1)**

2. The Malacca Land Rules 1966 [M. P.U. 3/1966] which are referred to as the “principal Rules” in these Rules, is amended by—

- (a) substitute the words RM3000.00 which included in Item 66A Schedule in column *Fees* to the words RM4000.00 or 2% from selling price, whichever is higher; and
- (b) inserting item in Schedule for new Item 66B after Item 66A as follows;
