

#### **RULES & REGULATIONS**

#### MMA MALACCA TREASURE HUNT 2014

- 1. Entries are open to all MALAYSIAN MEDICAL ASSOCIATION members / non-members & Immediate Family Members, medical students (MMA student members) and Allied Health Personnel.
- 2. Each participating vehicle will be given a clue or set of clues and handed directly in the form of "Tulips" The event is not a rally and as such speed will not contribute towards winning but may add to assessment of penalty points.
- 3. Participants are required to crack the clues and reach the place indicated by the clue or clues. However, some clues may require the participants to procure certain "treasures". All answer sheets & "treasures" are to be submitted to the officials at the finish line (Finish Control) by the stipulated time. "Treasures" are to be properly labeled and placed in the plastic bag provided.
- 4. The organizers reserve the right to accept a minimum of two persons (Driver & Navigator/s) and a maximum of four persons in any single vehicle.
- 5. Rights of the Organizers:

The organizers may, at their discretion:


- (a) Refuse any entry
- (b) Abandon, cancel or postpone the event without due notice in the event of bona fide unforeseen circumstances.
- (c) Exclude any person or vehicle appearing, upon examination to be not qualified to take part in the event.
- (d) Exclude any participant deemed unfit by reason of health, disability or being under the influence of alcohol or drugs.
- (e) Disqualify any participant who carries additional passengers not included in the Entry and Declaration Forms.
- (f) Disqualify if you loose your answer sheet.
- 6. All participants will be given the competitors numbers which is to be displayed on the vehicle & sponsor's stickers are to be affixed to their vehicle in the correct positions as indicated at the commencement of the event. It is suggested that a coat of polish / wax be applied to your car's surface before the stickers are affixed onto your car.
- 7. It is mandatory for the driver and navigator seated at the front to have their safety belts fastened.
- 8. Drivers must have in force a valid driver's license and a Motor Vehicles (Third Party Risk) Rules 1959 (Malaya) Insurance policy covering them against third party liability.

- 9. The participants will adhere to all rules and regulations of the Traffic & Government.
- 10. No assistance is to be expected from the organizers. Participants are responsible for ensuring that their vehicles are adequately provided with fuel, oil, water etc.
- 11. An amendment fee of RM 30.00 will be charged for every name change after an entry has been submitted.
- 12. Under no circumstances will any protest be entertained. Results and decisions made by the Clerk of the Course and the Organizing Committee shall be final and binding.
- 13. Participants are to note that the rules and regulations are applicable throughout the MMA MELAKA TREASURE HUNT 2008.
- 14. There will be scrutiny of vehicles.
